Entries must be:

postmarked June 20; or received in hand by 22

postmarked July 11; or received in hand by 13

postmarked Aug 22; or received in hand by 24

postmarked Sept 19; or received in hand by 21

Entries received after Monday accepted **IF possible; include post entry fee of \$5 per class**

No entry will be accepted/scheduled without payment, no entries accepted day of show.

Ribbons: To 7th place **Fees:** Youth under 18 \$15 per class, adult \$20 per class

Times: available on website www.southwindstables.com when schedule is complete.

Food: Check website regarding each show; Concession stand most every show.

Facilities: Show will be held in indoor sand ring. Large ring if weather permits, some classes may be held in small ring. Outdoor small grass ring if needed. Outdoor open grassy areas to warm up. No stalls available. Please keep horses out of barn. Please leave your dogs at home.

Attire: **Mandatory Helmet!** Safe riding shoes with a heel; shirt with a collar. Neat appearance.
